The funding is granted to Mentor institution to mentee the institution(s) and all the finances are dealt with Mentor and UGC. The Mentor has no financial commitment to mentee(s) except utilizing the funds from UGC grant for NAAC accreditation process as per UGC norms.

Duration

This MOU is at-will and may be modified by mutual consent of authorized officials from mentor and mentee institutions. This MOU shall become effective upon signature by the authorized officials from the mentor and mentee institution(s) and will remain in effect until modified or terminated by any one of the partners by mutual consent. In the absence of mutual agreement by the authorized officials this MOU shall end on after completion of NAAC accreditation process by NAAC with a minimum duration of one year from date of signing of MOU.







1. NOW THIS MOU WITNESSETH AS UNDER:

This is an agreement for a synergic alliance between visakha Government college for women and Suraj Krishna Greenaries for the social cause of recycling of Dry Waste and Environment Protection through recycling.

2. Time period: This MOU shall be for a period of one year commencing from the date of signing of this MOU.

3. Roles and Responsibilities of St.joseph college for women:

- a. To ensure source segregation of dry and wet waste at College premise through its Teaching staff, housekeeping staff and Students.
- b. Visakha Government college for women will give away any kind of paper waste, dry recyclable waste and old records to Suraj Krishna Greenaries at price agreed mutually. Suraj Krishna will pay as below rate:

White paper & News Paper:Rs.9/kg

Atta:Rs.3/Kg

Carton Boxes:Rs.7/kg

Hard Plastic(Pipes, Chairs, White drink bottles) :Rs.10/kg

Color Drinking bottles:Rs.3/kg

Low grade plastic:Rs.2/kg

Iron:Rs.12/Kg.

- c. Visakha Government college for women shall form Swachh WOW Andhra Pradesh Chapter in the college with Student Volunteers and adopt nearby Schools or Colonies to promote Source Segregation through student volunteers.
- d. Visakha Government college for women shall provide students for Internship in WOW Program.
- e. Visakha Government college for women shall motivate students to bring dry recyclables like paper, plastic, metal etc. from their home and donate to WOW initiative.
- f. Visakha Government college for women will put-up color-coded bins for waste segregation at different points in College premises.

4. Roles and Responsibilities of Suraj Krishna Greenaries:

- a. ITC-AGS will train the students and housekeeping staff on source segregation and through them inculcate the habit of source segregation among the other students.





ICAR-Indian Institute of Oil Palm Research, Pedavegi – 534 450, Andhra Pradesh, a constituent Research Institute of Indian Council of Agricultural Research (ICAR), a society registered under the Registration of Societies Act (Act XXI of 1860), (hereinafter referred to as ICAR-IIOPR, Pedavegi) of the one part.

AND

Visakha Govt. Degree College for Women, Visakhapatnam was established in 1975 through the Visakha Women's College Society. (Hereinafter referred to as VGDCW, Visakhapatnam) of the other part.

1.1.2 WHEREAS ICAR-Indian Institute of Oil Palm Research, Pedavegi – 534 450, Andhra Pradesh - is the India's premier institute for oil palm research having scientific staff with specializations in Agronomy, Plant Breeding, Horticulture, Seed Technology, Plant Protection, Plant Physiology, Social Sciences, Computer sciences, etc. These scientists are well trained in their field in India. There are several prestigious ongoing activities/ projects at ICAR- IIOPR.

C. Publications

- (i) The students would invariably be the senior author for the publications arising out of the research work conducted at the Institute, followed by Major Guide/ Advisor and Co-Major Advisor/Co-Guide in that order.
- (ii) In the publications on the research work carried at ICAR-IOPR, the Guide identified at the ICAR-IOPR will be the second author. The names of additional co-authors, depending upon their contribution in the research work, may be decided by mutual consent between the student and major Guide/ Advisor.
- (iii) The partnering institution ensures that the students submit at least one paper from Master's thesis and two papers from Ph. D thesis before thesis submission in order to prevent students leaving the Institute(s) without publishing any research publication from the thesis.

D. Intellectual Property Rights (IPRs)

The student will be expected to protect the Intellectual Property Rights generated or likely to be generated during his/her research work. The IPRs shall rest with the Indian Institute of Oil Palm Research/Indian Council of Agricultural Research. Patents/protections/knowledge generated will be shared in proportion as per the 'ICAR Guidelines for Intellectual Property Management and Technology Transfer /Commercialization' as amended from time to time.

2.3. *FORCE MAJEURE*

2.3.1. Neither party shall be held responsible for non-fulfillment of their respective obligations under this agreement due to the exigency of one or more of the *force majeure* events such as but not limited to Acts of God, war, flood, earthquakes, strike, lockouts, epidemics, riots, civil commotion, etc. provided on the occurrence and cessation of any such events, the party affected thereby shall give a notice in writing to the other party within one month of such occurrence or cessation. If the *force majeure* conditions continue beyond six months, the parties shall then mutually decide about the future course of action.

2.4. EFFECTIVE DATE, DURATION, TERMINATION OF THE AGREEMENT

- 2.4.1 The agreement shall be effective from 17/01/2020 and shall remain in force for a period of 36 months from the said date.
- 2.4.2 The agreement shall be deemed to expire on completion of the period, as in provision 2.4.1 unless extended by both the parties.
- 2.4.3 During the tenure of the agreement, parties hereto can terminate the agreement either for breach of any of the terms and conditions of this agreement or otherwise by giving a [2 months] notice in writing to the defaulting party. Failure of either party to terminate the agreement on account of breach or default by other shall not constitute a waiver of that party's right to terminate this agreement.
- 2.4.4 In the event of termination of the agreement vide provision 2.4.3 the rights and obligations of the parties thereto shall be settled by mutual discussion; the financial settlement shall take into consideration not only the expenditure incurred but also the expenditure committed by COUNCIL/INSTITUTE, as per ICAR guidelines.

(TCABS-E is a sister institution of Ty/DE-Toronto, Canada)

Purpose: This MoU is agreed upon by the both parties mentioned above, the Visakha Government Degree College for Women (will be referred to as VGDCW from here on) and The Center for Advanced-Applied Biological Sciences & Entrepreneurship (will be referred to as TCABS-E from here on), for mutual academic collaborations, student training and internships in Advanced-Applied Biomedical Sciences including Entrepreneurship.

Objectives: The goal of this MoU is to:

1. Promote HIGH IMPACT research and teaching collaborations between TCABS-E and the faculty of VGDCW both in Sciences and Arts for mutual benefits of both parties such as research publications, patents, grants & funding.
2. Enhance the employability of both UG and PG students from VGDCW by providing them with QUALITY practical oriented training at TCABS-E.

3. Provide INTERNSHIPS for students from VGDCW for a fee (please see the details under Internships section of this MoU).
4. Advise the students of VGDCW regarding higher studies and job search ABROAD (mainly in the U.S. and Canada).
5. Conduct special programs to stimulate high school students and organize symposia/conferences of mutual interest.

Internships: Both VGDCW and TCABS-E agree that the selection and participation of UG and PG students of VGDCW in the internship programs designed by the TCABS-E will be guided by the principles listed below:

Selection process:

- a. Minimum academic qualification of the participant should be 10+2 or intermediate. Additionally he/she should have been admitted into an UG or PG course at VGDCW at the time of selection and should be able to produce a valid student identification issued by VGDCW or a letter from the Principal of VGDCW certifying the student identity.
- b. TCABS-E will inform VGDCW regarding the internship programs either through email (soft copy) or through printed circulars (hard copy).
- c. The internship design will be entirely done by TCABS-E unless the student has specific interests that are within the scope of the internship. Faculty of VGDCW are highly encouraged to propose ideas to TCABS-E in the design of internships.
- d. The selected students are expected to commit full time for at least 45 days with more than 85% of attendance towards internship. The student has to decide this commitment before paying the registration fee to TCABS-E.
- e. Meritorious students will be periodically selected by TCABS-E for higher studies and employment opportunities either at TCABS-E or at affiliated institutions/collaborators in India or abroad (U.S. and Canada only).

Fee particulars:

- a. All students selected for the internship at TCABS-E will be charged a non-refundable registration fee of ₹ 1,000 payable to TCABS-E, before starting the internship. The date on the receipt issued by TCABS-E for the registration fees payment is considered as internship start date.
- b. All students who paid the registration fee mentioned above can participate in the internship program for a period of 10 days after which, they will be charged an internship fee of ₹ 4,000 payable to TCABS-E.
- c. Students may pay the internship fees within 10 days of their internship start date.(NOTE: Internship start date is written/printed on their receipt issued towards registration fee payment).
- d. All fees are non-refundable. However in severe cases with complete supporting documentation verified and certified by the Principal of VGDCW, TCABS-E may consider a partial refund only if the student had paid the full fee. NOTE: Registration fee of ₹ 1,000 will be still non-refundable even in severe cases.

- e. Additional charges will apply if damage occurs to TCABS-E due to students' misconduct.

Terms and Conditions: Both VGDCW and TCABS-E agree upon the following terms and conditions in order to execute this MoU:

1. This MoU will be effective from the date signed by representatives of VGDCW and TCABS-E.
2. It will remain valid until December 31st, 2020 and may be continued thereafter upon mutual agreement of both VGDCW and TCABS-E.
3. Either VGDCW or TCABS-E may terminate this MoU by giving a written notice to the other party 3 months in advance.
4. All research projects and outcomes (such as data, analysis, conclusions, etc.) designed at and/or by TCABS-E will remain TCABS-E's intellectual property and cannot be shared without prior permission from Dr. Ravikiran S. Yedidi, founder of TCABS-E.

Whereas the Institutional Member has its library located at Visakha Government Degree and PG College for Women, Visakhapatnam, Andhra Pradesh and has agreed to become a member of DELNET to use DELNET archives and services at this location only and promote and share its library resources with other institutional members of DELNET:

Now it is hereby agreed as follows:

The Institutional Member shall:

1. Use the DELNET databases for furthering its own research programmes and providing information to its users and Institutional Members of DELNET.
2. Use the software arranged by or through DELNET, if desired by the Institutional Member, on the machine owned by the Institutional Member at the above location.
3. Create records using international standards as adopted by DELNET from time to time (DELNET is recommending the creation of records using MARC, AACR II, the Library of Congress Subject Headings List and specialised thesauri, but libraries that have used other standards can still join DELNET and upgrade their records in due course of time).
4. Contribute the records of all items created by the Institutional Member to the Central Union Catalogues, Union Lists, etc. maintained by DELNET. The copyright of records created by the Institutional Member in its own machine will rest in the Institutional Member, but the copyright of the Central Union Catalogues shall rest in DELNET.
5. Pay an initial registration fee of Rs.5,000 + 18% GST to DELNET towards its Corpus Fund.
6. Pay Annual Membership Fee to DELNET for the use of its online resources and services at rates set by DELNET annually in advance on or before 1st April or the date of expiry of membership. (If membership dues for the applicable membership year are not received on or before the date of expiry of the current membership, a grace period of one month will be given, after which services will be temporarily suspended. The services will be started immediately after the receipt of annual payment within the following year. If the annual membership fee is not paid within one year of the date of expiry, the membership will stand cancelled. If the institution wants to use DELNET services again, the institutions will have to apply afresh and pay admission fee and annual membership fee payable by an Institutional Member at present is Rs.11,500 + 18% GST).
7. Pay all fees charges within thirty days from the date of DELNET invoice. The Institutional Member shall pay interest on all amounts not paid on the due date at the rate of 10% from the date of invoice to the date of payment.

The Institutional Member shall not:

1. Use the DELNET Union Catalogues, Union Lists and other databases for any commercial purpose. The Institutional Member shall not rent, sell or license the use of or deliver or release or otherwise part with the possession of the systems/materials/software or the DELNET Union Catalogues, Union Lists and databases or any part thereof to any third person.

2. Allow the use of the software/materials/database by any other person other than its own bonafide members of its library or information centre at the above location.

It is further agreed that:

1. DELNET will not accept records in the Central Union Catalogues that do not have the essential fields as prescribed by DELNET or those that contain typographical and factual mistakes. The Institutional Member has agreed to create records of DELNET standard.
2. The Institutional Member will have qualified manpower, a suitable computer and Internet access in their Library for the use of DELNET databases and services.
3. All charges towards telecommunication, stationary, etc. arising out of the use of DELNET databases and services by the Institutional Members will be borne by the Institutional Member.
4. The Institutional Member shall not be entitled to assign, sub-license or otherwise transfer the license whether in whole or in part to any other user.
5. If the Institutional Member located outside Delhi wants to invite DELNET staff to its institution for consultation or imparting training, the Institutional Member shall pay TA/DA to the DELNET staff as per DELNET norms.
6. If the Institutional Member does not create standard records, cooperate with other Institutional Members of DELNET in exchanging information, DELNET shall terminate the contract with a month's notice to the Institutional Member.
7. This contract may also be terminated by immediate notice in writing if DELNET or the Institutional Member has been responsible for a breach of its obligations and terms of this agreement. In such a case, the Institutional Member shall stop the use of the DELNET system facilities and databases with immediate effect and return any software/hardware provided by or through DELNET back to DELNET. All disputes between the parties shall be settled by negotiation.




